Information Collected by Opti-Harvest.com

We do not process this information in a way that is incompatible with this objective. We collect the following types of information from our Opti-Harvest.com users:

1. Information You Provide to Us: We receive and store any information you enter on our website or provide to us in any other way. You can choose not to provide us with certain information, but then you may not be able to take advantage of many of our special features.

2. Automatic Information:

We receive and store certain types of information whenever you interact with us. Opti-Harvest.com and its authorized agents automatically receive and record certain "traffic data" on their server logs from your browser including your IP address, Opti-Harvest.com cookie information, and the page you requested. Opti-Harvest.com uses this traffic data to help diagnose problems with its servers, analyze trends and administer the website.

Opti-Harvest.com may collect and, on any page, display the total counts that page has been viewed.

Many companies offer programs that help you to visit websites anonymously. While Opti-Harvest.com will not be able to provide you with a personalized experience if we cannot recognize you, we want you to be aware that these programs are available.

Cookies

Cookies are alphanumeric identifiers that we transfer to your computer's hard drive through your Web browser to enable our systems to recognize your browser and tell us how and when pages in our website are visited and by how many people. Opti-Harvest.com cookies do not collect personal information, and we do not combine information collected

through cookies with other personal information to tell us who you are or what your screen name or e-mail address is.
